

Compendium Insurance Brokers (Pty) Ltd (“Compendium”) – Catch a Car Competition Rules 2024:

Please ensure that you read over all the competition rules as entry into this competition automatically implies that the Participant has read, understood and agrees to these rules, which rules will be interpreted at the Promoter, being Compendium’s, sole discretion. Any decision made by Compendium in respect of the rules, will be final and binding. The competition rules will be construed, interpreted and enforced in accordance with the laws of the Republic of South Africa (“RSA”). The rules for the Catch a Car Competition are as follows:

 - 4.1. vary, postpone, suspend or cancel the competition and any prizes, or any aspect thereof, without notice at any time, at Compendium’s sole discretion. Should any variation, postponement, suspension or cancellation occur, the Participants agree to waive any rights, interests and expectations that they have in terms of this competition and acknowledge that the Participants shall have no recourse against Compendium, its affiliates and third-party suppliers; and
 - 4.2. disqualify any entrant suspected of fraud and/or dishonesty including but not limited to the falsifying of facts;
